

Person of Interest/Watch Lists

Custom Person of Interest or "Watch Lists" can be created and maintained in REDTAIL and searched when visitors check-in. Security officers can receive alerts if a person on the watch list enters the facility.

Visit Requests

Users of REDTAIL can schedule meetings and invite visitors. The system can be configured to pre-screen visitors based on security requirements.
